

While we serve as facilitators, you take center stage as a European policymaker. The Open European Dialogue is specialized in creating a secure space for dialogue and understanding between parliamentarians. You are invited to openly share your views with colleagues as we operate under the OED House Rules - you can trust that your view and that of others will be respected and heard.

The OED House Rules:

Adopt a spirit of Enquiry //

We invite you to adopt a spirit of enquiry and engage in more explorative thinking, spending more time on the diagnosis of a problem—asking yourself and others "why and how"—rather than jumping to your solution.

Embrace and respect diversity //

We embrace diversity and will ensure that all political perspectives are treated with respect. We ask you to do the same. We invite you to proactively engage with political points of view that are different from your own and approach controversy with civility.

Practice active listening //

The OED is as much about talking as it is about listening. We ask you to try to listen to understand rather than counter-react or contradict.

Foster a safe and brave space //

Feel free to speak your mind, you will not be quoted directly because we operate under Chatham House Rule. We encourage you to take risks and take the opportunity to challenge your own comfort zone.

Create enduring connections.

When you take part in our events, you become a member of the Open European Dialogue Network. We can ensure you will stay in touch with your colleagues after the dialogue – and can offer you a platform to launch an OED event of your choice which we help to plan and implement.

We are honored to welcome new and familiar faces alike to Lisbon and look forward to seeing you soon!

We will store baggage safely and transport it from the starting location to the end location while you are encouraged to mingle and roam.

THE OPEN EUROPEAN DIALOGUE AT A GLANCE

The Open European Dialogue is a politically neutral platform that aims to improve European politics by supporting policymakers in better understanding challenges and perspectives from across Europe. We do that by connecting European politicians across parties and countries, providing space for dialogue, and promoting innovative political conversations in ways that no one else does.

The network serves as a platform to the EU's ca. 10,000 national parliamentarians. Its active network comprises over 170 members from 23+ member states, representing around 70 different political parties.

Our members convene regularly for dialogues, conference calls, fact-finding missions, expert workshops, and other activities.

Since 2017, the network also empowers parliamentarians to develop their own cooperative, cross-party and cross-country spin-off initiatives. Our policy experts from four internationally renowned think tanks offer input to ensure the highest quality of dialogue.
